

WIKY Vacation Club 2015 OFFICIAL RULES

- .01 NAME OF PROMOTION: WIKY Vacation Club
- .02 SPONSORS: Holiday Inn Resort in Panama City Beach, Florida
- .03 DESCRIPTION OF PRIZE(S): 3 - 3 day, 2 night stay in a Standard Room at the Holiday Inn Resort in Panama City Beach, Florida (a \$500 value). Weekly prize winners announced on May 8th, May 15th & May 22nd, 2015 after 5pm CDT.
- Grand Prize is a 4 Night Stay for 4 in the Penthouse Suite at the Holiday Inn Resort in Panama City Beach, Florida(a \$4,000 value). Prize winner will be announced on May 29th after 5pm CDT.

HOW TO ENTER – ADDENDUM A

1. These rules govern WIKY Vacation Club (the “Promotion”) being conducted by WIKY-FM (the “Station”) beginning on Thursday, April 30, 2015 at 12:00PM CDT and ending on Friday, May 29, 2015 at 6:00PM CDT.
2. To participate in the Promotion, listeners can log onto www.wiky.com and follow the links and instructions to register their information.
3. Winners can also enter the contest by mailing in their information on a 3x5 index card to “WIKY Vacation Club – Entry,” Attn: Promotions, 1162 Mt Auburn Road, Evansville, IN 47720. The index card must include name, address, date of birth, home phone number and secondary phone number (if applicable).

Other rules and restrictions:

Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner’s full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other Midwest Communications Radio station in Station’s market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a completed W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

By participating in the Promotion, the winner agrees to have the winner’s name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate or modify the Promotion. If the Promotion is terminated before the original end date, the Station will select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station’s website. Failure to comply with the rules of the Promotion may result in a contestant’s disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

The Station reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel or modify the Promotion and shall not be required to award a substitute prize.

Released Parties including Midwest Communications are not responsible for lost, late, incomplete, illegible, inaccurate, delayed, stolen, misdirected, undelivered or garbled entries; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the promotion, including, without limitation, errors or difficulties which may occur in connection with the administration of the promotion, the processing of entries, the announcement of the prizes or in any promotions-related materials.

Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the promotion. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this promotion or downloading materials from or use of the website. Persons who tamper with or abuse any aspect of the promotion or website, who are in violation of these Official Rules, or who act in an unsportsmanlike or disruptive manner as solely determined by Sponsor, will be disqualified and all associated entries will be void.

Sponsor reserves the right at its sole discretion to suspend, modify or terminate the promotion for any reason, including, but not limited to, should any portion of the promotion be, in Sponsor's sole opinion, compromised by virus, worms, bugs, unauthorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, and, if terminated, at its discretion, randomly select the winners from among all eligible, non-suspect entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. Automated entries are prohibited, and any use of automated devices will cause disqualification. Midwest Communications reserves the right to amend the contest rules and procedures at any time, providing such changes are announced on-the-air prior to their implementation when practical. Midwest Communications has the right to end the promotion at any time and may change the date of the event at any time.

Sponsor reserves the right at its sole discretion, to disqualify any individual (who tampers with the entry process. Entrants may not register with multiple email addresses nor may entrants use any other device or artifice to register multiple times or as multiple registrants. Any entrant who attempts to enter with multiple email addresses under multiple identities or uses any device or artifice to enter multiple times will be disqualified and forfeits any and all

prizes won, in Sponsor's discretion. Midwest Communications has the right to disqualify any individual from the contest at any time, for any reason.

Winners are non-transferable.

METHOD OF SELECTION OF WINNER - ADDENDUM B

1. Once the listener is registered online or through a mailed entry, they will listen for their name to be announced on 104.1 FM WIKY every weekday between the hours of 9:00AM – 5:00PM CDT beginning on May 4, 2015 through May 29, 2015.
2. The Station will randomly select names from online and mailed entries. The WIKY On-Air Personality will announce a different name every hour (between 9am - 5pm CDT each weekday). If your name is announced by the On-Air Personality during the WIKY Vacation Club Promotion, you will have 10 minutes to call the WIKY studio at (812) 451-2104 or 1-800- 454-WIKY to be qualified to be in the drawings for the weekly prizes as well as the Grand Prize. Once a listener qualifies, they will be eligible to win in the remaining drawings.
3. After 5pm CDT on May 8th, May 15th, and May 22nd, we will randomly draw a weekly winner from ALL of the qualifiers(listeners who called back in less than 10 minutes). The weekly winner will win a 3 day, 2 night stay in a Standard Room at the Holiday Inn Resort in Panama City Beach, FL(\$500 value). The winner will be announced after 5pm CDT on May 8th, May 15th, and May 22nd. Weekly winners will still be eligible to win the Grand Prize on May 29th. The Grand Prize Winner of the 4 Night Stay for 4 in the Penthouse Suite at the Holiday Inn Resort in Panama City Beach, FL will be drawn from all qualifiers and announced on May 29th after 5pm CDT.
4. A family member or a friend may not call in on behalf of the selected individual to claim the prize. All eligible callers/winners will be required to provide all information requested including their full name, complete address (including zip code), phone number and date of birth in order to be eligible to win. Any attempts to deceive the Station will result in immediate disqualification.

Texting and any form of social media is NOT an acceptable form on contacting WIKY. The person must call the WIKY studio to be qualified.
6. Due to delays in the WIKY online and app streaming of its broadcast signal, listeners to the online and app stream may not be able to participate in or may be disadvantaged in participating in on-air contests.
7. In event of any dispute involving the contest, the decisions of the Midwest Communications management is final. All matters not specifically mentioned in these rules shall be determined at the sole discretion of the Midwest Communications management.
8. All winners must execute any required affidavit of eligibility and/or liability release within thirty (30) days of winning or prize will be forfeited.

The Promotion is open to all persons who are 18 years of age or older who are legal residents of the Evansville, IN DMA (as defined by the Nielsen Company). Employees of Station, its licensee, the licensee's parent, subsidiary and affiliated entities, Station's advertising and promotional agencies, its participating sponsors, other radio stations in the tri-state metropolitan area, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
