HOW TO ENTER - ADDENDUM A

Listen to WNCY 100.3 FM. Be the correct number random caller when the "20 For 20 Call To Win Sounder" is aired weekdays between 6am & 7pm to 920- 465-1003 or 800-359-1003.

Note: due to the nature of our programs that are heard on-line over the Internet, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station, and will be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means that when WNCY announces winning names in this contest, listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contest on a conventional FM radio.

ADDENDUM B

METHOD OF SELECTION OF WINNER

Correct random caller will be awarded that day's designated concert tickets or concert flyaway.

Winner and Guest must appear in person prior to complete legal paperwork at a pre-determined appointment for concert getaways. Once paperwork is completed winner and guest information cannot be changed.
