This correspondence is Notice, pursuant to the Worker Adjustment Retraining Notification Act, 29 U.S.C. § 2101 et seq. and Wis. Stat. § 109.07, that Wausau Paper Mills, LLC (“Wausau Paper”) will be permanently closing its facility located at 202 Second Street, Brokaw, Wisconsin, 54417 on February 10, 2012 or within 13 days thereafter.


Wausau Paper expects to terminate all employees on February 10, 2012, or any date during the thirteen (13) day period thereafter. Those employees set forth in Attachment A are not represented by a Union, are not subject to the terms of a Collective Bargaining Agreement, and have no bumping rights. The remaining employees set forth in Attachment B are represented by the Union indicated in Attachment B and may have bumping rights.
