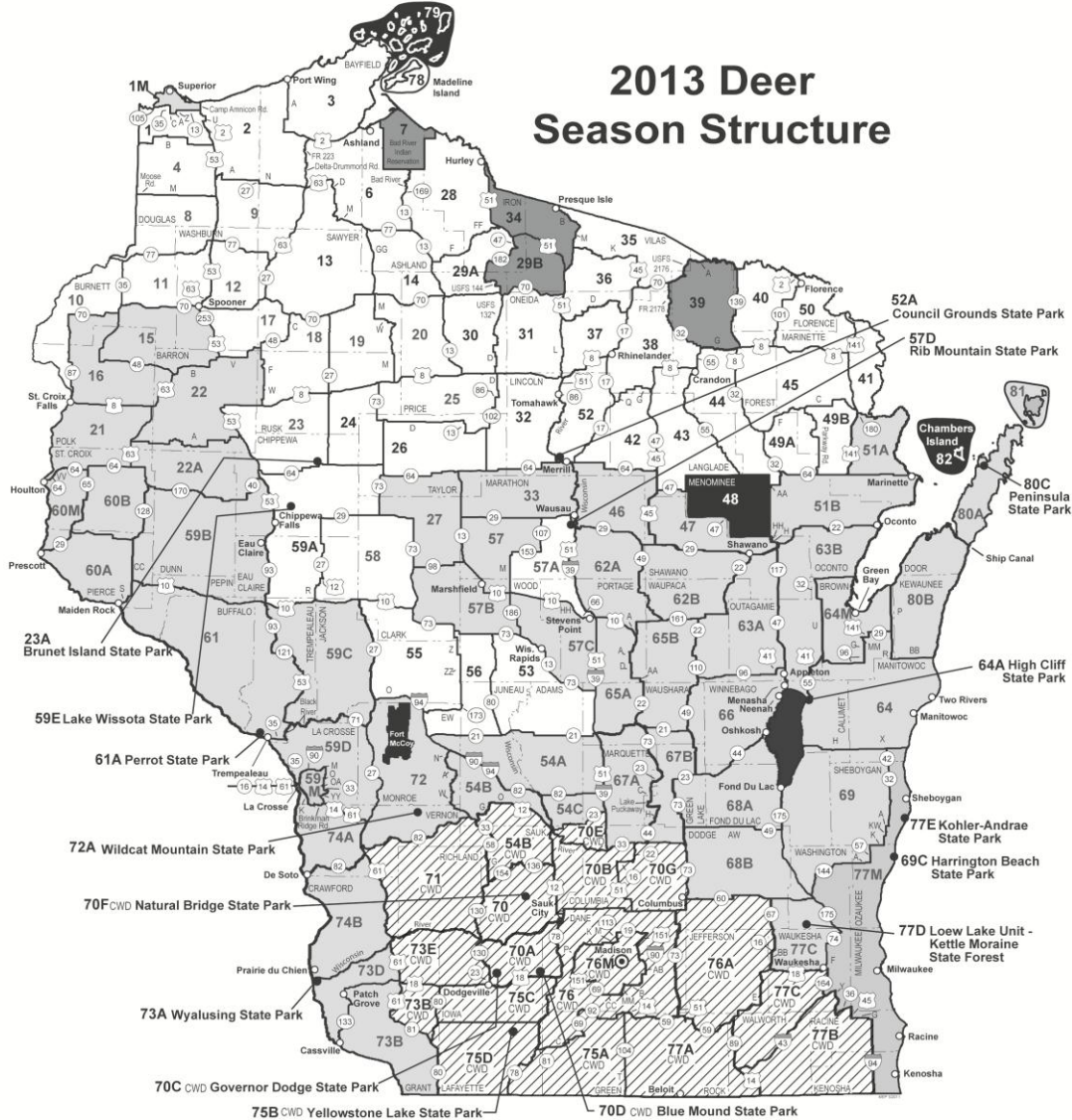


# 2013 Wisconsin Antlerless Deer Permit Information

## Regular Units

### Permit Levels and Sales Information

#### Regular Deer Management Units

All but four of the following Regular units have antlerless tags available for purchase. The cost is \$12 each for Wisconsin residents, \$20 each for non-residents, and \$5 each for 10-11 yr. olds. Hunters may purchase one unit-specific tag per day until the unit is sold out or until the hunting season ends.

#### *How Are Permit Levels Determined?*

Antlerless permits in Regular units are limited in number. Hunters sometimes assume that 1000 permits will mean 1000 deer will be killed. This is not the case. Antlerless harvest goals (quotas) are established for each unit, and a unit-specific success rate (achieved by hunters during previous deer seasons) is applied to determine the number of permits necessary to reach the harvest goal. For example, in DMU 1 it will require 1,150 tags at a 35% success rate to reach the harvest goal of 400 antlerless deer ( $400 / .35 = 1,150$ ).

## Herd Control and CWD Units Permit Levels and Sales Information

**Herd Control Units:** Antlerless Deer Carcass Tags for Herd Control units may be purchased by both residents and non-residents for \$2 each at any license vendor or online until the close of the deer seasons. They may be used in any Herd Control or CWD unit. There is no limit to the number allowed for purchase.

## State Park Units Access Permit Levels and Sales Information

### State Park Units with Access Permits

Those interested in hunting deer in Brunet Island (23A), Council Grounds (52A), Rib Mountain (57D), Lake Wissota (59E), Perrot (61A), High Cliff (64A), Harrington Beach (69C), Wildcat Mountain (72A) Wyalusing (73A), Loew Lake (77D), Kohler-Andrae (77E) or Peninsula (80C) State Park must purchase a State Park Access Permit (\$3). Access Permit and antlerless tag sales begin August 17<sup>th</sup> and will continue until sold out or the deer hunting seasons end. Some state parks may have special season dates or weapon restrictions. See *2013 Deer Hunting Regulations* for details. Special state park deer hunting regulations will be mailed to those who purchase access permits early and can also be found at the respective park office or on the DNR website: <http://dnr.wi.gov>. # General Deer Season Information

## 2013 Deer Hunting Season Dates

**Gun:** Oct 5 & 6 Youth (Statewide)

Nov 23 – Dec. 1 (Statewide)

Dec 12-15 Antlerless Only (Statewide)

Dec 24 - Jan 5, 2014 (CWD units only)

**Muzzleloader:** Dec. 2-11 (Statewide)

**Archery:** Sept 14 - Nov 21 (Early season - Statewide)

Sept 14 - Jan 5, 2014 (CWD units only)

Dec 12-15 Antlerless Only (Statewide)

Nov 23 - Jan 5, 2014 (Late season - Statewide)

## **December Antlerless-Only Gun Hunts**

The December antlerless-only gun hunt will be in effect for all DMUs statewide, **except 7, 29B, 34, & 39**, Non-Quota Areas and most State Park Units. Buck Authorization Stickers valid only for use in CWD units may be earned during these hunts if antlerless deer are harvested within a CWD unit. Only the harvest of antlerless deer is permitted by both gun and archery hunters statewide during this hunt.

**State Park and Metro Units:** Season dates in State Parks and Metro Deer Management Units may differ from the statewide seasons listed above. Refer to the *2013 Wisconsin Deer Hunting Regulations* for specific season information.

## Bonus Buck regulations in CWD Units

Hunters in CWD units are allowed to harvest one buck without any pre-qualifications on both a gun deer license and bow deer license.

Additional bucks may also be harvested by first shooting an antlerless deer. These “bonus bucks” must be tagged using an antlerless or CWD Deer Carcass Tag with a Buck Authorization Sticker attached to it OR an unregistered antlerless deer tagged by the same hunter must accompany the buck until both are registered together.

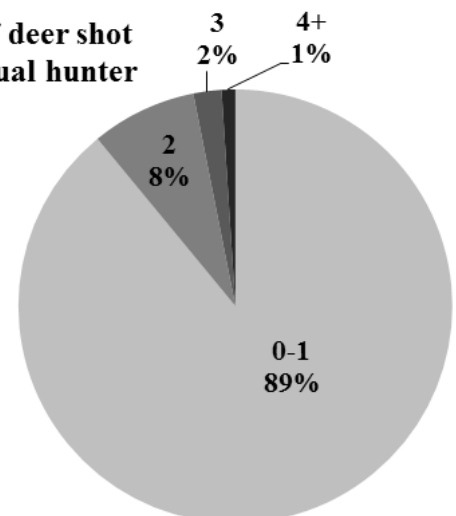
## Bonus Buck Pre-Qualification

- Hunters that registered an antlerless deer during the 2012 deer hunting season in the CWD units should have received a yellow 2012 Buck Authorization Sticker from a deer registration station. **This sticker, properly affixed to a antlerless or CWD Deer Carcass Tag, may be used for tagging additional bucks harvested in CWD units during the 2013 hunting season.**
- Hunters may receive one green Buck Authorization Sticker for each antlerless deer harvested and registered in CWD units during the 2013 hunting season. Request a 2013 Buck Authorization Sticker from the registration station upon registering your deer if you wish to hunt for additional bucks.

## ***How Many Deer Do Individual Hunters Harvest?***

It is a common misconception that a sizeable percentage of deer hunters shoot more than one deer each year. Deer registration data totals for each hunter indicate that this is not the case. In 2012, 89% of Wisconsin licensed archery and gun deer hunters did not shoot more than one deer. Hunter surveys mailed to randomly-drawn Wisconsin deer hunters following the hunting seasons have indicated that one deer is all most hunters wish to consume in a year, and therefore all they wish to harvest.
