Cassandra Wohlgemuth, Sheboygan Police Department, being first duly sworn on oath deposes and says on information and belief:

**Count 1: FIRST DEGREE INTENTIONAL HOMICIDE**

The above-named defendant, on or about January 24, 2014, in the City and County of Sheboygan, State of Wisconsin, did cause the death of Emilio E Torres, DOB 3/26/72, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a) Wis. Stats.

Upon conviction for this offense, **a Class A Felony, the defendant shall be sentenced to imprisonment for life.**

The basis of complainant's charge of such offense is: Official reports prepared by Detective Joel Clark of the Sheboygan Police Department, as well as other officers of that Department as described below. Said reports indicate that on January 29, 2014, at about 10:00 p.m., Officer Brian Inger was dispatched to 3501 Lakeshore Road, Apt. 3B in Sheboygan where he met with Shelly L. Torres, DOB 8/11/71. Shelly was concerned that she was unable to contact her ex-husband, Emilio E. Torres, DOB 3/26/72, for several days. She stated that although they are divorced, she and Emilio are close friends and they usually contact each other every day. She stated the last time she had contact with Emilio was on January 23, 2014 at about 8:30 p.m. Her attempts to contact Emilio since then by phone or text were unsuccessful.

Shelly stated she contacted her son, Dorian Torres, who lived with Emilio. She stated Dorian stated Emilio had just packed up his things and went to Texas, although he didn't know where in Texas. He also told Shelly that Emilio had given his car, a 2007 Audi 4.2 Quattro sedan, to Dorian. Shelly stated she found this odd as Emilio loved that vehicle and, in her opinion, would never leave it behind.

Shelly stated she tried contacting Emilio on his Facebook page but that his account had been deleted. She became more concerned when she was later contacted by Dorian asking for Emilio's PINs for his bank cards. She stated Dorian told her Emilio, in addition to him giving Dorian his Audi, had also given Dorian all his bank cards and credit cards. Shelly stated she refused to provide any PINs to Dorian, finding it odd that Emilio would give Dorian these cards without giving him PINs. She stated Dorian had also asked her for the last four numbers of Emilio's social security number, which she also refused to provide. Shelly stated she subsequently contacted Emilio's work place who had no information on Emilio but advised her to call police. Police subsequently contacted Emilio's employer and was informed that Emilio had last worked on Thursday, January 23, 2014, and had not returned to work since then and had not contacted the company concerning his absence from work, which was unusual for Emilio as he was deemed a reliable employee.

Shelly also stated there was "stress" between Emilio and Dorian as they argued frequently as Dorian has a problem with "authority" figures.

Shelly stated she had a key to Emilio's apartment which was located at 2132 Meadowland Drive, Apt. 101 in Sheboygan. Shelly, Officer Inger and Sergeant Tim Patton went to that location to check on Emilio's welfare. Shelly entered by using her key, followed by the two officers, and the group saw Dorian sitting on a couch watching television. Officer Inger noted that a towel had been jammed into the base of the apartment door from the inside, and that there was a trail of potpourri leading to the rear of the apartment.

Officer Inger stayed with Dorian while Sergeant Patton and Shelly went towards the bedroom, which door was closed. Upon entering the bedroom, Sgt. Patton noted the room was extremely cold, although the rest of the apartment was heated. Sgt. Patton discovered there was a window open in the room. Shelly noted there was a stain of some kind on Emilio's bed which she hadn't seen before. She also pointed out that a pile of clothes on the floor belonged to Emilio, as well as a pile of Emilio's mail. She also recognized Emilio's wallet on the floor, which proved to be empty. Shelly also noted that a vinyl shower curtain was missing from the bathroom which was without any shower curtain.

Sgt. Patton noticed there was a bed box spring leaning against a bedroom wall and when he pulled it away from the wall saw it had hidden what appeared to be a body completely wrapped in a vinyl-type sheet with duct tape around the head and feet. At that point, Shelly became extremely emotional, sobbing and crying.

Sgt. Patton made contact with Dorian who looked at the wrapped body saying, "What is that?". When told it looked like a body, Dorian disagreed. Sgt. Patton arrested Dorian without incident.

After obtaining a search warrant, the apartment was processed by Sheboygan Police personnel. The body, still wrapped, was eventually transferred to the Sheboygan County Morgue where later that day Dr. Mark Witeck, a forensic pathologist, performed an autopsy after the wrapping was removed and saved as evidence. The body was subsequently identified as Emilio Torres. Dr. Witeck gave a preliminary cause of death as a depressed skull fracture and that there was evidence of multiple blows to the head with a blunt object.
