2. A photo of the child will also need to be submitted. The person submitting the photo must be the mother, father, or legal guardian of the baby in the photo. The picture that is uploaded must be a current photo of the baby. Each baby that is entered must be birth to under 24 months of age as of Jan. 1st, 2014. The photo can not be a professional photo taken by a photographer due to copyright rules.

METHOD OF SELECTION OF WINNER

The Voting Schedule will be as follows:

i. Voting Period 1
