WNCY "Boarding Call" Sounder will be played on air at random times between 6:00am thru 8:00pm Monday, November 16 thru Sunday, November 22, 2015.

Note: due to the nature of our programs that are heard on-line over the Internet, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station, and will be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means that when WNCY plays the "Boarding Call" sounder in this contest, listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contest on a conventional FM radio.
