Sgt. Eugene Wielgosh, Sheboygan County Sheriff Department, being first duly sworn on oath deposes and says on information and belief:

Count 1: BURGLARY OF A BUILDING OR DWELLING

Defendant.

The above-named defendant on Thursday, December 17, 2009, Sheboygan County, Wisconsin, did intentionally enter a dwelling, without the consent of the person in lawful possession of the place, and with intent to steal, contrary to sec. 943.10(1m)(a), 939.50(3)(f) Wis. Stats.

Upon conviction for this offense, a Class F Felony, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

Count 2: MISDEMEANOR THEFT

The above-named defendant on Thursday, December 17, 2009, Sheboygan County, Wisconsin, did unlawfully, intentionally take and carry away the movable property of another, without that person's consent and with the intent to deprive the owner permanently of possession of such property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: MISDEMEANOR THEFT

The above-named defendant on Wednesday, November 23, 2011, Sheboygan County, Wisconsin, did unlawfully, intentionally retain possession of the movable property of another, without that person's consent and with the intent to deprive the owner permanently of possession of such property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 4: MISDEMEANOR THEFT

The above-named defendant on Wednesday, November 23, 2011, Sheboygan County, Wisconsin, did unlawfully, intentionally retain possession of the movable property of another, without that person's consent and with the intent to deprive the owner permanently of possession of such property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 5: BURGLARY OF A BUILDING OR DWELLING

The above-named defendant on Sunday, September 19, 2010, in the City of Sheboygan, Sheboygan County, Wisconsin, did intentionally enter a dwelling, , without the consent of the person in lawful possession of the place, and with intent to steal, contrary to sec. 943.10(1m)(a), 939.50(3)(f) Wis. Stats.

Upon conviction for this offense, a Class F Felony, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

Count 6: THEFT - MOVABLE PROPERTY (SPECIAL FACTS)

The above-named defendant on Sunday, September 19, 2010, in the City of Sheboygan, Sheboygan County, Wisconsin, did intentionally take and carry away movable property of Scott J Zajkowski, which property is a firearm, without consent, and with intent to permanently

deprive the owner of possession of the property, contrary to sec. 943.20(1) (a) and (3)(d), 939.50(3)(h) Wis. Stats.

Upon conviction for this offense, a Class H Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 7: THEFT - MOVABLE PROPERTY (SPECIAL FACTS)

The above-named defendant on Sunday, September 19, 2010, in the City of Sheboygan, Sheboygan County, Wisconsin, did intentionally take and carry away movable property of Scott J Zajkowski, which property is a firearm, without consent, and with intent to permanently deprive the owner of possession of the property, contrary to sec. 943.20(1)(a) and (3)(d), 939.50(3)(h) Wis. Stats.

Upon conviction for this offense, a Class H Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 8: MISDEMEANOR THEFT

The above-named defendant on Tuesday, May 17, 2011, Sheboygan County, Wisconsin, did unlawfully, intentionally retain possession of the movable property of another, without that person's consent and with the intent to deprive the owner permanently of possession of such property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 9: BURGLARY OF A BUILDING OR DWELLING

The above-named defendant on Saturday, June 19, 2010, Sheboygan County, Wisconsin, did intentionally enter a dwelling, , without the consent of the person in lawful possession of the place, and with intent to steal,, contrary to sec. 943.10(1m)(a), 939.50(3)(f) Wis. Stats.

Upon conviction for this offense, a Class F Felony, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

Count 10: MISDEMEANOR THEFT

The above-named defendant on Saturday, June 19, 2010, Sheboygan County, Wisconsin, did unlawfully, intentionally take and carry away the movable property of another, without that person's consent and with the intent to deprive the owner permanently of possession of such property, contrary to sec. 943.20(1)(a) and (3)(a), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

The basis of complainant's charge of such offense is: Official reports prepared by Detective Cameron Stewart of the Sheboygan Police Department and Detectives Gerald Urban and Mark Mancl, both of the Sheboygan County Sheriff's Department, which reports indicate that on March 21, 2012, during the execution of a Search Warrant at the home of Dennis Petrie, DOB 04/14/50, hereinafter referred to as the Defendant, located at N5047 Big Bend Lane, in the Town of Sheboygan Falls, County of Sheboygan, State of Wisconsin, law enforcement recovered a charm bracelet with numerous charm pendants attached to it that had the names and dates of birth engraved on the pendants. On March 26, 2012, Sheboygan Police Department Detective Paul Olson photographed these pieces of jewelry.

On April 3, 2012, Sheboygan County Detective Gerald Urban was informed by Sheboygan Police Department Detective Matthew Walsh that he reviewed evidentiary photographs related to the Dennis Petrie burglary investigations, and upon viewing photograph #0601, which was a picture of the charm bracelet with numerous charm pendants, Detective Walsh did an independent follow-up investigation in order to determine who the owner of that charm bracelet was. Detective Walsh was able to determine that the charm bracelet was most likely owned by Joseph Strohmeyer, DOB 05/19/43, because he found that Joseph had filed a burglary report with the Sheboygan County Sheriff's Department on December 17, 2009. A review of the police report of the alleged burglary reveals that someone had forced a side garage door located on the north side of Joseph's residence. Joseph estimated that the alleged burglary would have occurred sometime between 9:00AM and 3:30PM. Inside the residence, officers noticed that many dressers and drawers were gone through and that jewelry was stolen.

On April 3, 2012, Detective Urban conducted a follow-up investigation by making telephone contact with Joseph concerning this charm bracelet. During this conversation, Joseph told Detective Urban that the charm bracelet was inherited by his wife, Mary Strohmeyer, DOB 01/08/44, after Mary's mother, Betty Rosenstein, passed away in the year 2001. Detective Urban informed Joseph of the names engraved on the charm bracelet pendants and he stated all of those names on the charm bracelet were Strohmeyer family members, including his own children. Joseph also told Detective Urban that he was acquainted with the Defendant and that they engaged in conversations which involved Joseph telling the Defendant that his wife works at Torke Coffee in Sheboygan during the daytime and that he sold Christmas trees in the month of December every year and were usually gone away from the home between the hours of 9:00AM and 8:00PM during those days. Joseph went on to say that neither he or his wife were home when the home was burglarized on December 17, 2009. Detective Urban then made arrangements with Joseph to meet him at the Sheboygan County Sheriff's Department to view photographs of the jewelry.

On April 5, 2012, Detective Urban met with Joseph and Mary at the Sheboygan County Sheriff's Department. Joseph and Mary immediately recognized a picture of the charm bracelet as the same charm bracelet that Mary inherited from her late mother, Betty. They were able to identify all of the names and dates of birth identified in the charm bracelet.

It is upon information and belief that neither Joseph or Mary gave anyone permission to enter their home and take the charm bracelet. It is also upon information and belief that the value of the charm bracelet is less than \$2500.00.

On April 5, 2012, Detective Urban conducted a follow-up investigation to a burglary and theft from a locked shed and yard at W5346 CTH N, in the Town of Lyndon, County of Sheboygan, State of Wisconsin, that was reported to the Sheboygan County Sheriff's Department on November 23, 2011. In that report a red Chilton single-axle utility trailer was reported stolen from outside in the yard on the property and it matched the description of a red Chilton single-axle utility trailer that was observed and photographed by law enforcement during the execution of a Search Warrant on the property of the Defendant at the end of March. This red Chilton single-axle utility trailer reported stolen was owned by David E. Andrews, DOB 05/18/48.

On April 9, 2012, Detective Urban met with David at the Sheboygan County Sheriff's Department and showed him a series of four

photographs of the utility trailer that was photographed during the execution of the Search Warrant. David noted that the front inside portion of the trailer had a rub mark on it from a tractor that he regularly towed in it and a paint spill of the same color of paint they used to paint his backyard fence and the paint spill mark was left by the paint sprayer that he towed in his trailer for that purpose. David also pointed out that the bulldog jack attached to the receiver had a bent shoe from dragging on the ground just like his stolen trailer had and that the jack's locking pin was missing a security chain just like the stolen trailer. David stated that based on those unique identifiers he observed in the photographs, he was certain that the trailer was owned by him. A short time after David left Detective Urban's office, Detective Urban was contacted by David and David advised Detective Urban that his wife, Tamara Andrews, found the original sales invoice for that trailer and that the Vehicle Identification Number on the sales invoice matched the Vehicle Identification Number on the red Chilton single-axle utility trailer presently on the Defendant's property. This sales receipt also reveals that David paid \$1207.50 for the utility trailer.

On April 9, 2012, Detective Urban conducted follow-up investigation to the reported burglary and theft at W5346 CTH N in the Town of Lyndon. This property is owned by David's son, Curt Andrews, DOB 09/18/78. Detective Urban met with Curt at the Sheboygan County Sheriff's Department impound shed where Detective Urban allowed Curt to view all of the property that was seized during the execution of the Search Warrant on the Defendant's property. Curt brought along several owner's manuals of power tools that were stolen from his locked storage shed and many of those owner's manuals matched the description of the power tools he reported stolen from his locked storage shed on November 23, 2011. Curt positively identified the following property items as being owned by him that was seized during the execution of the Search Warrant:

- A Dewalt double bevel sliding compound miter saw, Model DW718. Curt further identified the rigid table that the compound miter saw was mounted on by the fact that there was a brown stain from brown wood stain on the table's fence that he remembered being in the exact location of the one that was stolen from him.
- A Dewalt planer, Model DW735. Curt further identified this Dewalt planer by the fact that it was equipped with a rubber hose coupler with two medal band clamps that were attached to the planer's exhaust system that he mounted on the exhaust system.

- A Ryobi electric circular saw inside of a gray Ryobi saw case, Model CSB141LZ. Curt further identified this Ryobi circular saw by the fact that the owner's manual was still inside the gray case for that saw in the same location that he had left it when it was stolen.
- A Milwaukee brand 1/2" hammer drill, Model #537820, inside of a red plastic Milwaukee case. Curt further identified this Milwaukee 1/2" hammer drill by the fact that the owner's manual was still inside the red plastic case where he had left it when it was stolen.
- A Black & Decker band saw, Model BDBS100
- A Black & Decker bench belt sander, Model BDSA100
- 12 Irwin brand quick grip wood clamps of various sizes; a Black & Decker Gecko grip level; a Bosch 3/4" round over router bit still inside of its case; and a Surebonder staple gun, Model 9600.
- A Porter Cable Dovtail Jig, Model 4210
- An Irwin spade drill bit set inside of an Irwin plastic case, sizes 3/8" through 1-1/2". Curt identified this Irwin spade drill bit set as his because of the fact that he had placed two extra spade drill bits sizes 3/4" and 1" inside of the case before it was stolen.

Curt had reported additional tools and property that were stolen during the burglary that were not among the property at the Sheboygan County Sheriff's Department impound shed. Detective Urban then met with Curt at the Sheboygan County Sheriff's Department where Detective Urban allowed Curt to view evidentiary photographs that were taken at the Defendant's property during the execution of the Search Warrant. Curt was able to identify additional tools and other property that were not seized during the execution of the Search Warrant and still at the Defendant's property. This property included:

- A Craftsman brand cordless drill
- A Miles Craft brand base plate/bushing set. Curt described this base plate/bushing set as a router mounting plate.
- Six Irwin brand wood clamps
- A Craftsman brand black plastic case that Curt Andrews indicated was the case for the aforementioned Craftsman drill and a flashlight.
- A stereo with a CD player and speakers
- A Dewalt brand black plastic toolbox containing various drill accessories, including Irwin tools and other assorted tools that Curt positively identified as his, and the fact that they

were arranged inside of this toolbox just as he had left them before they were stolen.

- A Skil brand belt sander, which Curt further identified by the fact that it had a blue colored sand belt on the sander.
- Two pairs of Tubbs brand snowshoes
- A Milwaukee brand plunge router

It should be noted that during the initial burglary investigation in November of 2011, Curt sent Deputy Putz an email on November 30, 2011, at 8:52AM, with a complete list of all the property that was stolen from his locked storage shed and that list included property items that were identified by Curt either at the Sheboygan County Sheriff's Department impound shed or in the photographs taken at the Defendant's property.

It is upon information and belief that neither David or Curt gave anyone permission to take any of the above mentioned property from Curt's locked storage shed and yard.

In late March, Detective Stewart assisted the Sheboygan County Sheriff's Department with an execution of Search Warrant and consent searches at the Defendant's property. During the execution of the Search Warrant and consent search, numerous firearms were removed from the residence. Information was gathered by law enforcement that the suspect, the Defendant, had targeted residences that were open for estate sales in which the deceased's information was placed into an obituary. Detective Stewart recalled a case from approximately two years earlier in which a burglary was reported at 1925 South 21st Street, in the City of Sheboygan, County of Sheboygan, State of Wisconsin, on September 19, 2010. Upon reviewing police reports from the sons of the deceased, Chad and Scott Zajkowski, Detective Stewart observed three firearms matching the description of firearms stolen from the Zajkowski residence during the estate sale. The first firearm was a Remington 870 shotgun, the second was a JC Higgins, 12-gauge, pump, shotgun with an adjustable choke and the third was a Mossberg, 12-gauge shotgun with both a slug and bird barrel.

On April 6, 2012, Detective Stewart and Detective Norlander of the Sheboygan County Sheriff's Department, met with Scott at the Sheboygan County Sheriff's Department. The first firearm, the Remington 870 shotgun, was immediately identified as a firearm not belonging to the family. However, upon observing the JC Higgins firearm, Scott was able to positively identify it as the one stolen during the estate sale on South 21st Street in September of 2010. This was positively identified by him because he remembered the

action to be extremely loose and indeed when Detective Stewart manipulated the shotgun, he found the action to be extremely loose. The third firearm, the Mossberg, prior to Scott arriving, was manipulated by Detective Norlander. Detective Norlander was able to move the slug barrel and replace it with the birdshot barrel interchangeably. The birdshot barrel and the slug barrel both had Mossberg imprinted on them. When meeting with Scott, Scott informed the Detective that the Mossberg is actually his brother's gun and Scott informed the detectives that his brother has one identical to it. Scott informed the detectives that he had spoken to his brother and his brother had indicated that the receiver underneath the gun where slugs can be inserted to be fired should be rusting. Upon flipping the gun over, Detective Stewart observed that the receiver is, indeed, rusted.

It is upon information and belief that neither Scott or his brother gave anyone permission to take either of the guns. Your complainant reports that a review of the initial burglary complaint shows that the JC Higgins shotgun was valued at \$150.00 and the Mossberg shotgun was valued at \$250.00.

On March 26, 2012, Detective Urban and Detective Walsh were assigned to follow up on this investigation. They arranged to meet with Ellery G. Stam, DOB 01/05/82. On that date Ellery met with the detectives at the Sheboygan County Sheriff's Department. Ellery told detectives that the Defendant showed him a bunch of tools in the back of his truck back in April or May of 2011 between noon and 1:00PM in the driveway of Dennis Schlichting's house. Ellery stated there numerous Passload gas nailers, a Sawzall, a 22 concrete bullet nailer and chop saws. Ellery stated that he was suspicious about where the Defendant would have gotten these items from because it was enough equipment to run a small construction company with and Ellery noted that as long as he has known the Defendant, he has been unemployed. Ellery said he has known the Defendant since a Christmas party in 2006. Ellery stated that during this time, the Defendant has not had a regular job, as far as he knows. Ellery stated that while he was talking with the Defendant back in April or May, the Defendant was drinking alcohol out of a bottle.

Ellery stated that he asked the Defendant where he got these tools. Ellery stated that the Defendant told him that he reads the newspapers and visits estate sales. Ellery stated the Defendant told him he reads the paper and then goes back at night. Ellery stated, "Dennis Petrie admitted to me he was plucking off estate sales."

Ellery stated he could use money and when he refers to that, he states that he could use money from a CrimeStopper's reward tip. Ellery stated he listens to CrimeStoppers report tips on the radio and has often thought, as does his girlfriend, Denise Schlichting, that the Defendant was involved in these thefts.

On March 21, 2012, during the execution of a Search Warrant at the Defendant's home, law enforcement observed and photographed a red and black log splitter. This red and black log splitter fit the description of a log splitter that was reported stolen to the Sheboygan County Sheriff's Department on May 17, 2011, by Lyman C. Theobald, DOB 11/09/54.

On April 12, 2012, Detective Urban made telephone contact with Lyman. Lyman stated that the description of the log splitter Detective Urban provided him matched the description of the log splitter that was stolen from his yard at W4271 CTH O, Town of Sheboygan Falls, County of Sheboygan, State of Wisconsin. Lyman stated he also still had the owner's manual for the log splitter and upon checking the owner's manual, he stated the owner's manual indicated that the model number of the log splitter was 1032822 and that model number matched the SKU number of 1032822 that was on the tractor supply company decal on the log splitter still on the Defendant's property.

It is upon information and belief that Lyman did not give anyone permission to remove his log splitter from his property.

On March 22, 2012, Detective Mancl of the Sheboygan County Sheriff's Department, was assisting in the execution of the Search Warrant at the Defendant's residence. At that time, two separate items were located that are supporters for long guns. One of these was a bipod and the other was monopod. Both of them were brand named Trigger Stick, manufactured by Primos. Also recovered during the execution of the Search Warrant was a Bose wave radio.

On April 11, 2012, Detective Mancl was assigned to review a burglary that occurred in 2009, to determine if it was possibly related to the items recovered during the execution of the Search Warrant at the Defendant's property. This burglary was reported on December 23, 2009 and was reported as a burglary to vacant residence, whose owner had died just weeks before the burglary had occurred. The vacant residence was located at 809 Panther Avenue, in the Town of Wilson, County of Sheboygan, State of Wisconsin. At that time the property owner's grandson, Kevin J. Westenberger, DOB 02/27/79, had reported the break-in to the property owner's residence. In that

report, a Bose wave radio with serial number 018815C90285978A, was reported stolen, as well as a monopod.

Detective Mancl compared the photograph of the monopod that was reported stolen from the Westenberger residence and the photograph of the monopod at the Defendant's residence and he noted that they appeared to be similar in make and model. They were similar in color, style, length, and design, including the locations of screws in the handle area just below the support for the firearm. Detective Mancl did a more recent check on the Cabella website and determined that this item is approximately \$50.00 in value currently.

Detective Mancl was also aware of officers' recovering a stolen Bose wave radio during the execution of the Search Warrant at the Defendant's residence. Detective Mancl compared that to the number that had been reported to officers during the initial burglary investigation at the Westenberger residence. Detective Mancl noted that this was one and the same serial number and item. It was reported that this item was valued at approximately \$300.00 at the time it was reported stolen.

On March 21, 2012, during the execution of the Search Warrant at the Defendant's property, law enforcement recovered four pieces of jewelry that matched the description of stolen jewelry from a burglary reported to the Sheboygan County Sheriff's Department on June 19, 2010, at N2347 Cardinal Lane, in the Town of Holland, County of Sheboygan, State of Wisconsin. It should be noted that this burglary was reported during a Gibson Girls Estate Sale. The recovered jewelry included a pearl necklace contained inside a gray velvet jewelry box with a price tag of \$185.00 attached to; a faux diamond necklace and earring set contained inside a gold trimmed jewelry box with a price tag of \$85.00 attached to it; a gold chain necklace with a ruby heart shaped pendant attached to the necklace with a price tag of \$195.00 attached to it contained inside a white jewelry box, and an empty gray velvet jewelry box with a price tag of \$350.00 inside of it.

On April 2, 2012, Sheboygan Police Department Detective Matthew Walsh conducted follow-up investigation by meeting with Gibson Girls Estate Sales owner, Karen L. Schmeiser, d.o.b. DOB 07/08/43. During this meeting Karen positively identified each piece of jewelry as being stolen from the Bamberger estate sale at N2347 Cardinal Lane, Town of Holland.

It is upon information and belief that none of the Bamberger family gave anyone permission to take these four pieces of jewelry from the

estate sale. Additionally Karen also did not give anyone permission to take these pieces of jewelry from the estate sale.

On March 26, 2012, Detective Urban and Detective Walsh continued their investigation reference this multi-jurisdictional burglary ring. Detectives Urban and Walsh met with Ellery Stam, who indicated that he knew Dennis Petrie. Ellery Stam indicated that Dennis Petrie showed him a boat. The detectives asked Ellery to tell them about the incident. Ellery stated that he had asked Dennis about finding a cheap boat. Ellery stated the next day, Dennis located a boat and showed him a boat on the Schlichting property. Ellery stated this would have been in April or May of 2011, between noon and 1:00PM in the driveway at Dennis Schlichting's house. Ellery stated he asked Dennis Petrie where he got the boat. Dennis replied, "It doesn't matter." Ellery stated Dennis said, "Don't ask me that." Ellery stated he told Dennis, "I'm not going to buy a stolen boat." Ellery stated he was suspicious of the boat and where it came from because of the timing of how Dennis Petrie located it in a day and was wanting to sell it to him quickly without a title and with a serial number that was bolted onto it. Ellery continually referenced the boat as being an aluminum boat with a bolted serial number on it. Ellery stated he talked to Dennis and asked him where he got the boat.

At the time, the same day as he viewed the boat with Dennis Petrie, Ellery stated that Dennis Petrie showed him a bunch of tools in the back of the truck. Ellery stated there were numerous Passload gas nailers, a Sawzall, a 22 concrete bullet nailer, and chop saws. Ellery stated that he was suspicious about where Dennis Petrie would have gotten these items from because it was equipment to run a small construction with and noted that as long as he has known Dennis Petrie, he has been unemployed. Ellery stated that while he was talking with Dennis Petrie, Dennis was drinking alcohol out of a bottle. Ellery stated that he asked Dennis Petrie where he got the tools and Ellery stated that Dennis told him he reads newspapers and visits estate sales. Ellery stated Dennis told him he reads the paper and then goes back at night. Ellery stated that Dennis described the incident with the boat from near Fond du Lac and that he hooked up the boat and then went into a pole barn and loaded the boat up with tools. Ellery stated Dennis told him the stuff was laid out on tables and that the boat had been sitting outside and that the tools came from inside of a pole shed and he loaded up the boat so that the tools outweighed the capacity of the trailer hitch. Ellery stated that Dennis told him that he then went back into the pole shed and found a different ball hitch trailer to support the
